#### 09/17/15: **"Emerging Trends in the Languages of Sexual/Gender Identities"**

The wave of research on sexual fluidity plus the greater acceptance for open discussion about sexual identity/orientation have created challenges to communicating with clients and understanding the changing paradigms of clients. This presentation will focus on issues of "languaging" when dealing with sexual identity/orientation. Included will be attention to the impact of the current trends for challenging binary categorizations of sexual and gender identities.

#### 3/12/15 CO CREATING A MORE INCLUSIVE CULTURE FOR LGBTQ AFFIRMING 9 a.m.–1 p.m. THERAPISTS: THE DIALOGUE

An extension of the February 18<sup>th</sup> in-service, "Co creating a more inclusive culture for LGBTQ Affirming Therapists," this experiential workshop will take the challenges that face the Guild to become a more effectively inclusive organization to the personal. We will address inclusion as a practice that goes beyond having a progressive mind and being open to individual differences i.e., race, sexuality, gender expression and other identities. The practice of diversity and inclusion is an active lifelong developmental process that involves intentional self-reflection, self-examination and action. Using dialogue, narratives, and experiential activities we will explore the relevance and usefulness of deepening our commitment to and practice of inclusion. Participants will have opportunities to expand and deepen both personal and collective cultural humility.

The objective of this workshop is to increase our knowledge and resources for personal and collective development with the goal of becoming more accessible to LGBTQ clients of color and actively connecting with LGBTQ affirming therapists of color.
